The vendors gave the visitors a chance to buy and eat their delicious foods. Red Creek Wildlife Center also came to visit the park. Red Creek is a wonderful foundation who nurtures wildlife of all kinds back to health. A hawk who had been saved by the center came to visit the park also on that day and I think the rescued hawk we saw soaring into the sky early this year might have also flown over the day's activities.

One of the park's latest improvements is the paved walking trail that meanders through the park property. The walking trail takes you across the stream on two bridges. The new bridge was built entirely by the township's Public Works Department who have been active in the park all year. The trail was paved by the coop of the Southern Schuylkill County Township Public Works Departments. The Wayne Township Public Works Department has also cut three new walking trails into the wooded area at the top of the park. This gives walkers a different approach to walking and a little tougher experience. At this time, the playground equipment is being erected by the pavilion. It might

# WAYNE TOWNSHIP RECYCLING

As summer turns to fall and the sun sets lower in the evening sky, we look back on what has taken place in our township of Wayne over the long warm days of summer which are now behind us.

After many years of deterioration and for the safe passage of vehicles, PennDOT has started work on SR 183. We are very happy to see the roadway being addressed and repaved in some areas. SR 183 has been milled down to re-establish a cross slope. It has then received

a "scratch and level" course of asphalt and then received a new 9.5 mm hot mix asphalt overlay. This process was long overdue, but those of us who use SR 183 every day are very happy to see this work started and hope that this work will continue all the way to the Appalachian Trail and the Berks County/Schuylkill County line.

The Wayne Township Road Department used a process known as cold in-place asphalt recycling

(CIPR), to re-construct Miller Road. CIPR is an environmentally approved system that uses all of the old, oxidized asphalt in the roadway. The total thickness of the old asphalt (5-inch depth) is cut by way of a down-cutting milling head. The cutting head and drum have 240 carbide teeth that cut down hill producing a two-inch minus gradation of RAP (Reclaimed Asphalt Pavement or millings). As the recycling train moves along the roadway, it picks up a previously placed one percent of Portland cement that has been placed on top of the roadway. The re-sized asphalt material, Portland cement and a small amount of water then enter the cutting/ mixing chamber of the machine. The material is then homogeneously mixed so that all the particles of asphalt are coated with the new liquid bituminous binder, in this case a CSS-1h Emulsified Asphalt. The recycling

eliminates all the cracks, potholes in the roadway and can also change the percentage of the cross-slope of the roadway allowing for storm water to flow safely along the shoulders of the roadway. From the cutting chamber, the recycled material is then lifted up from the pavement and placed by way of two conveyors into a bituminous paver. The paver then places the material onto the sub-base correcting the slope to the required depth of the specifications and any new width of the

paved roadway.

The recycled material is then compacted using 15-ton steel double-drum vibratory rollers and a 22-ton pneumatic (rubber) tired roller. The ompaction of the new recycled material is completed

once the density and compaction effort has reached its specified limits. After

a period of two weeks, the township road department placed a 1.5-inch, 9.5 mm hot mix asphalt-wearing surface over the entire recycled base.

The townships in southern Schuylkill County share a lot of heavier workloads with other municipalities including South Manheim Township, West Brunswick Township, East Brunswick Township and Upper Tulpehocken Township of Berks County. The cost of paving projects and equipment to construct highway projects is of great expense but by being part of a co-op of townships, the cost is kept in check and allows township road departments easy access to manpower and equipment. In the past several years West Brunswick Township, Washington Township, North Manheim Township and Wayne Township have used the CIPR method to rejuvenate their worst roadways in their respective townships. Upper Tulpehocken Township and Bethel Township of Berks County have also used the process over the past four years.

## Frog Hollow Walk in the Woods

Lead walks in Frog Hollow, 170 Stone Mountain Road (just outside of Friedensburg) have been organized by Friends of Frog Hollow.

### WAYNE TOWNSHIP, SCHUYLKILL COUNTY Low & Moderate INCOME HOUSING Rehabilitation Program

The housing rehabilitation program for the Township of Wayne is designed to encourage low/moderate income owner-occupants to restore their homes to a decent, safe and sanitary condition.

The housing rehabilitation program assistance will be in the form of grants/non-interest bearing forgiveness loans that would be forgiven at a rate of 25% per annum over a period of four years. A no-interest mortgage/lien will be placed on homes that are rehabilitated through the program in accordance with the interest-free four-year forgiveness loan.

The following current income limits were effective as of June 15, 2023. They represent the income by family size for the area as reported by HUD. The Township Supervisors will revise these limits whenever HUD adjusts the Home Income Limits for Schuylkill County.

1 person	\$44,650
2 person	\$51,000
3 person	\$57,400
4 person	\$63,750
5 person	\$68,850
6 person	\$73,950
7 person	\$79,050
8 person	\$84,150

Annual income is the gross amount of income that household members are expected to receive during the coming 12 months.

Income qualification alone does not insure that funding will be received for rehabilitation.

All requirements of the program must be met in order to qualify. Below are some of the additional requirements for the program.

The unit to be rehabilitated must be owned and occupied by the applicant. Please note that mobile homes owned by the applicant that are located in a mobile home park will require a lease agreement between the applicant and the mobile home park. The lease agreement must be for a minimum of five years. Real estate taxes on the property to be rehabilitated must be paid up to date as well as other municipal taxes and fees. The owner will be required to provide evidence of property insurance. Flood insurance must be provided for homes that are located in the 100 year floodplain. The amount for the rehabilitation cannot exceed limits for the program.
